2022 Virtual Tea Party

Once again, in 2022, we held our annual Tea Party via Zoom. Our own President Suzanna Rawlins provided a detailed presentation on the South Carolina Regulation Movement.

The Regulation Movement is South Carolina is typically not as well-known as the North Carolina Regulator Movement, and there are some distinct differences. Here's a sample from the Origins slide of President Rawlins' presentation:

The Regulators of South Carolina formed during the mid-1760s and were active mainly between 1767 and 1769.

- Comprised of backcountry settlers who banded together in 1767 in response to a wave of crime that swept through the region in the aftermath of a war with the Cherokee Bandit gangs the Cherokee Indian War (1759-1761)
- The purpose was to restore law and order and establish institutions of local government.
- Why? Commons House of Assembly had failed on several occasions to provide funding for peace officers and local courts.
